That's why you should download, install, and use Adobe's latest version of _**Photoshop Elements**_ (ACR) if you want to edit your photos. _**Adobe Camera Raw**_ (ACR) is the editing program that makes the _**Layers**_ feature work in Photoshop Elements. ACR has several features that let you do many more things than you can on a photo. You can retouch, retime, resize, and crop images just like in the editing programs found in the full Adobe Photoshop CS suite, but you can also adjust the color and contrast of photos in a similar way. ACR can open, edit, and save many of the same RAW formats —and even JPEGs — that Photoshop CS can use, so you don't have to worry about compatibility with other applications and any extensions you may have installed. ACR is a free download, and it's compatible with the following versions of Photoshop Elements: * **Version 9 and earlier:** These versions use the _**Adobe Camera Raw 5.1**_ plug-in. The easiest way to get ACR is to find it online at www.adobe.com/photoshop/acr, where you can download the plug-in as a ZIP file. * **Version 11:** ACR 1.0 is bundled with Photoshop Elements 11. After you install the plug-in and start the program, you see the Welcome screen shown in Figure 4-4. If you click Open, you're ready to go. To open photos, click the Photos button on the Welcome screen (refer to Figure 4-4), and then open a folder or single image. You don't need to drag it into the image window, so you can click the image thumbnail in the window; its edge marks show you where the image will go. (You don't see the marks on a background image.) It provides in relevant part that: (a) The Federal Home Loan Bank Board shall make a finding of fact that in its judgment the state agency has met or has not met the conditions of § 1816 of this title (as the case may be). In making such a finding, the Board shall give consideration to all relevant factors, including the effect on competition of the acquisition (or proposed acquisition) and the amount of financial assistance received by the state agency in connection with the acquisition (or proposed acquisition). (b) If the Board makes a finding under subsection (a) that the acquisition or proposed acquisition is consistent with the Bank's statutory responsibilities, the Board shall order the termination of the Federal charter of the bank by the end of the then-current year. (c) If the Board makes a finding under subsection (a) that the acquisition or proposed acquisition is not consistent with the Bank's statutory responsibilities, the Board shall order the bank to be terminated, and such termination shall become effective not later than the end of the next business day following the date on which the Board has published in the Federal Register its order. (An order terminating the charter shall be effective not later than the end of the next business day following the date on which the Board has published in the Federal Register its order.) (d)(1) A state agency, upon certification by the Board, may be relieved of the requirement of a finding under subsection (a) by providing to the Board a copy of the certification.
